- 6. Fee: \$3,000
- 7. Participants

  - b. Total participants 20
- 8. It is a 80 hours programme & certificate would be issued upon satisfactory completion of the following
  - a. At least 75% attendance of the monthly session (≥7 training sessions)
  - b. Submit 2 presentations of interesting poisoning cases from his/ her own unit
  - c. Attend at least 12 hours of accredited training activities
  - d. Completed the MCQ assessment at the end of the program
